Re: Violent physical abuse of your daughter Hillary Adams - open letter

Dear Judge Adams,

I am appalled by your physical assault of your daughter as recorded on video. As concerning is your wife's active participation in controlling your child for the beating. This video is evidence not of a punishment or a 'spanking' but of criminal assault.

It concerns me - as a children's advocate, a parent and a Guardian ad Litem - that you are a judge who handles cases of child abuse. Your obvious ease - and cold calculation - at abusing your own child renders your qualifications for your position null and void.

Despite your daughters plea that people provide you with help there is, in my experience, no help to be had for you. Your mind-set is deeply engrained and will only change when and if you decide to. No amount of enforced therapy will help you, nor will it help those you have hurt. Your lack of remorse and minimization of the attack speaks volumes.

I'll go out on a limb here and suggest that you blame your daughter for the beating and for releasing the video; a common trait among child abusers - blaming the victim. What she did prior to the assault is irrelevant; what is relevant are your actions for which there is no excuse.

Abusers of children like yourself are typically not one-off offenders; this video may record just one time in what may have been a pattern of such events in your household. Police investigation and time will tell.

You should tender your resignation immediately. What you do after that is up to you; or the police.
